SUMMARY

Net Proceeds from the Share Offer

- Based on the Offer Price of HK\$0.3 per Offer Share, the net proceeds from the issue of the Offer Shares under the Share Offer to be received by the Company, after deducting the underwriting fees and other expenses payable by the Company in relation to the Share Offer, are estimated to be approximately HK\$35.5 million. The Company intends to apply such net proceeds from the Share Offer in accordance with the purposes set out in the section headed “Statement of Business Objectives and Use of Proceeds” in the Prospectus.

Hong Kong Public Offering

- The Hong Kong Offer Shares initially offered under the Hong Kong Public Offering have been significantly over-subscribed. A total of 1,801 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms, through **HK eIPO White Form** and by giving **electronic application instructions** to HKSCC via CCASS for a total of 231,320,000 Hong Kong Offer Shares, representing approximately 11.57 times of the total number of 20,000,000 Hong Kong Offer Shares initially available for subscription.
- Accordingly, the reallocation of the Offer Shares as described in the section headed “Structure of the Share Offer — The Hong Kong Public Offering — Reallocation” in the Prospectus has not been applied.

Placing
