VOLUNTARY ANNOUNCEMENT MEMORANDUM OF UNDERSTANDING IN RELATION TO PROPOSED ACQUISITION

MEMORANDUM OF UNDERSTANDING

The board (the "Board") of directors (the "Directors") of the Company is pleased to announce that on 25 January 2022, In Technical Productions Limited, a wholly-owned subsidiary of the Company (the "Buyer"), entered into a non-legally binding memorandum of understanding (the "MOU") with Shenzhen Xinhang Information Technology Limited* (深圳市鑫杭信息科技有限公司) ("Shenzhen Xinhang"), pursuant to which the Buyer intends to acquire equity interest in Shenzhen Xinhang by way of capital injection or transfer of equity interest (the "Proposed Acquisition").

The principal terms of the MOU are as follows:

Date: 25 January 2022 (after trading hours)

Parties: (1) the Buyer; and

(2) Shenzhen Xinhang.

To the best of the Directors' knowledge, information and belief, after having made all reasonable enquiries, Shenzhen Xinhang and the ultimate beneficial owner of Shenzhen Xinhang are third parties independent of the Company and its connected persons (as defined under the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the "GEM Listing Rules")) as at the date of this announcement.

Amount of Equity Interest to be Acquired and Consideration

The (i) amount of equity interest in Shenzhen Xinhang to be acquired by the Buyer and (ii) the consideration for the Proposed Acquisition are subject to further negotiations between the parties to the MOU before entering into any Formal Agreement (as defined below).

Exclusivity

During the period of three months from the date of the MOU (the "Exclusivity Period"), Shenzhen Xinhang will negotiate with the Buyer exclusively on the Proposed Acquisition and will not (whether directly or indirectly through companies under the control of Shenzhen Xinhang, its subsidiaries, substantial shareholders, directors, staff, senior management, agents or representatives) discuss, negotiate and/or enter into any agreement or understanding with any other party with respect to the Proposed Acquisition or the MOU.

Due diligence review

Pursuant to the MOU, the Buyer shall be entitled to conduct due diligence review on the business, financial and legal affairs of Shenzhen Xinhang upon signing of the MOU. Shenzhen Xinhang and its agent shall use their best endeavours to assist the Buyer in completing the due diligence review on Shenzhen Xinhang.

Formal Agreement

The Buyer and Shenzhen Xinhang shall use their best endeavours to agree on the terms of and enter into a legally binding formal agreement in relation to the Proposed Acquisition (the "Formal Agreement") within the Exclusivity Period.

Termination

Unless mutually agreed otherwise in writing, the MOU will terminate at the earlier of:

- (i) the expiry of the Exclusivity Period;
- (ii) the date on which the Buyer gives notice in writing to Shenzhen Xinhang in accordance with the terms of the MOU that the results of the due diligence review are unsatisfactory; or
- (iii) the date of execution of the Formal Agreement.

Non-legally Binding Effect

Save for the provisions as to exclusivity, confidentiality, termination of the MOU, costs, and governing law and jurisdiction, the MOU does not constitute a legally binding agreement on the parties to the MOU.

Shenzhen Xinhang is a company established in the People's Republic of China (the "PRC") and based in Shenzhen, Guangdong province and is principally engaged in the development and provision of information technology services in the PRC.

The Company is an investment holding company. The Group is principally engaged in the provision of visual display solution services in Hong Kong, the PRC, Taiwan and Macau.

The Board is of the view that the transactions contemplated in the MOU, if materialised, will enable the Group to offer a wider range of and better quality of services and to explore more business opportunity in the PRC market, and therefore are in the interests of the Company and its shareholders as a whole.
